







1. The quotationer has to submit the attested copy of certified firm /Company/ manufactures/ authorised Dealer having up to date dealership /GST Regd. certificate, PAN card etc. with ISO specification. No power of attorney of affidavit shall be allowed for the above documents.
2. Paper cost Rs.2,000/- (Rupees two thousand) only in shape of Bank Draft in favour of Executive Officer, municipality Subarnapur payable at Subarnapur shall be attached with the quotation paper.
3. The successful quotationer shall have to deposit @ 3 % of the total order value in shape of DD towards Security Money which will be refunded after completion of guarantee period or completion of Local fund Audit whichever is later.
4. The material shall be specified brands specification only as mentioned in quotation schedule and strictly in accordance with relevant ISI specification, and the price list of specified brand must be submitted with quotation.
5. Guarantee certificate from manufacturer of the above materials must be furnished in the quotation paper with an undertaking that the materials be replaced immediately, if found any defect within the guarantee period.
6. The successful quotationer shall have to produce a demo Prototype Decal (high quality stickers meant for vehicles) of size 8x8 inches made of water proof durable material & shall be placed in the middle of the Basket for distinct visibility as per the directions of the Municipal Authority.
7. The successful quotationer shall have to fix the high quality sticker in the baskets & in case of covered baskets, prescribed decals shall be pasted in the middle outer front area of the basket and similarly in case of wired baskets, prescribed decals pasted in a fibre frame shall be fixed in the middle outer front of the wired basket.
8. Supply of the items at Sonepur Municipality within 7 days from the date of issue of order at his own risk and cost.
9. The materials will be inspected by the Executive Officer and his technical staffs.
10. Offer received incomplete in any manner will be summarily rejected.
11. The quotation will be valid for one year.
12. Payment will be made as per the availability of fund.
13. Any other information can be had from the office of the Executive Officer Subarnapur Municipality, Subarnapur.
14. Any legal dispute arise shall be settled under the jurisdiction of Subarnapur court. And no power of attorney or Affidavit shall be allowed.
