- 2 Paper cost Rs.2,000/- (Rupees two thousand) only in shape of Bank Draft in favour of Executive Officer, municipality Subarnapur payable at Subarnapur shall be attached with the quotation paper.
- 3 The successful quotationer shall have to deposit @ 3 % of the total order value in shape of DD towards Security Money which will be refunded after completion of guarantee period or completion of Local fund Audit whichever is later.
- 4 The vehicle shall be specified brands specification only as mentioned in quotation schedule and the price list of specified brand must be submitted with quotation.
