
## EXPRESSION OF INTEREST

The quotation should reach the undersigned on or before. 26.07.2023 up to 12 PM. The following terms & condition will apply.


1. The interested party is required to apply in the enclosed format from 14.07.2023 to 26.07.2023 up to 12 Pm. The vehicle will be engaged for one year from July 23 to Jun 2024.
2. The Vehicle must be in good running condition. It should also be able to cover all GPS Villages of Dunguripali Block in all weathers.
3. The vehicle should have up to date Tax clearance, Insurance coverage & fitness. The driver of the vehicle should have a valid driving license.
4. The owner of the vehicle should quote the expecting daily hire charges, which should not exceed the prescribed limit i.e. Rs. 1000.00/- per day including fuel.
5. The maintenance of the vehicle, The salary of the driver & cost of fuel & lubricant shall be borne by the owner concerned.
6. The vehicle shall be stationed at Office of Junior Engineer RWSS Phatamunda.
7. The payment of the hire charges for the month shall be made in the succeeding month through A/C payee cheque, or by transfer credit to the respective Bank Account in State Bank of India, Dunguripali only to the vehicle owner only, subject to availability of funds.
8. The Expression of interest should be accompanied with Xerox Copy of RC Book, driving License, Tax clearance, fitness Certificate.
9. The selected vehicle owner shall make an arrangement with the undersigned for engagement of his vehicle which shall be for one year only.
10. In every matter decision of the undersigned shall be final & binding.






