Introduction:

Odisha Adarsha Vidyalaya(OAV) is an ambitious initiative by the Govt. of Odisha to provide quality education in English medium to the rural children of Odisha practically at no cost or at best at low cost. It has been planned to open one OAV in each block of Odisha in phased manner. The beginning has been made with 100 OAVs in 100 blocks with effect from the academic year 2016-17 and opening of new OAVs in left out blocks are continuing. All OAVs are being affiliated to CBSE. The entry level is Class-VI and it has been planned to map these institutions Centres of excellence with provision of education up-to class-XII.

Odisha Adarsha Vidyalayas will have infrastructure and facilities of the same standard as Kendriya Vidyalaya with stipulation on Pupil-Teacher ratio, ICT usages, holistic educational environment, appropriate curriculum and emphasis on "**outlay and outcome**". The objective is to provide high quality English medium Education to the rural talents.

Key features of Odisha Adarsha Vidyalaya:

- The objective is to provide high quality English medium Education to the rural talents.
- Vidyalaya will have holistic and integral approach touching upon physical & aesthetic development in addition to academic.
- There are 17 rooms in ground floor and 19 rooms in 1st floor including 18 class rooms and other facilities.
- The Vidyalaya will have adequate ICT infrastructure and internet connectivity.
- There will be sufficient scope for sports and co-curricular activities.
- There is provision of Art, Music and Computer Teacher besides subject teachers.
- Special emphasis will be given on teaching of Science, Math and English.
- There is provision of well-equipped laboratories and library.
- Medium of instruction is English and the Vidyalaya is affiliated to CBSE, New Delhi.
- The Vidyalayas will have appropriate pace setting activities, so that Vidyalayas in the neighbourhood can benefit from it.
- The classes will be from VI to XII with intake capacity of 40 in each section.
- The reservation of seats for students will be as per the percentage of SC & ST population in the respective Blocks at Entry level (Class-VI).
- All efforts will be made to make it really a centre of excellence.

+2 Higher Secondary (Science Stream) at a glance

(A) Scholastic Areas:

1. There will be 5 subjects in class-XI. These are (i) English Core (Code 301)
(ii) Mathematics (Code 041 or 241)
(iii) Physics (Code 042)
(iv) Chemistry (Code 043)
(v) Biology (Code 044)
2. There is no alternative subject in addition to above 5 subjects. All 5 subjects of class XI will be continued to class-XII without any change.

3. A student can opt either of 041 or 241 in mathematics and subjects once opted in class XI cannot be changed till completion of class XII
4. The student passed with basic mathematics(241) in class X is not eligible to take Mathematics (041)in class XI
5. The student eligible to study mathematics (041) is eligible to study Mathematics (241) but vice versa is not true.
6. Mere filling of one subject code in application form does not give right of allotment of that specific subject especially in mathematics.
7. Regarding allotment of subject the decision taken by school level empowered committee is final and binding to all and nobody can challenge it.
8. If any student violates the admission guidelines mentioned in this prospectus or submits incomplete application in any respect will be liable for cancellation of his/her candidature without assigning any reason thereof.
9. The physics, Chemistry & Biology subjects have practical of 30 marks and theory of 70 marks.

(B) Co-Scholastic Areas:

The Co-Scholastic activities are used as both cognitive and non-cognitive development of students can take place by exploring the child to the lesson on scholastic subjects and non-scholastic subjects. Each school has to keep following three co-scholastic subjects:-

- (i) General studies.
- (ii) Health & Physical Education
- (iii) Work Experience.

Admission Guidelines:

- The students who have passed from OAV where class X is upgraded to class XI will be selected first in order of their merit determined on the basis of marks secured in CBSE class X examination.
- The merit will be decided on the basis of marks secured by five main subjects in class X examination. Marks obtained in additional subject and seventh subject will not be considered for obtaining of merit.
- If seats are still found vacant, students of other Odisha Adarsha Vidyalayas of the district may be considered for admission on the basis of merit. Followed by other government CBSE affiliated schools where OAV student will be given priority
- If, still seats remain vacant, the admission may take place in the following order of preference
 - I. Students of the Government High Schools within the same block
 - II. Students of Private High Schools within the block.
 - III. Students of Government High schools of other blocks of the district.
 - IV. Students of the Private/Public High schools of other blocks of the district.

This practice will continue till class XI is opened in all Odisha Adarsha Vidyalayas
In all cases the selection shall be on the basis of merit (five main subject based) with separate list

- (a) Based on parent OAV,
- (b) Based on other OAVS of the Sonapur District.
- (c) Other categories

- V. In each category mentioned in admission guidelines IV if students secured same weightage for a particular position then aggregate(combine) marks of Mathematics (041)and Science(086) will be taken for merit., and further if aggregate marks of mathematics and science again coincides then student securing maximum marks in Mathematics 041 will be selected to that particular place. If again it coincides the student senior in terms date of birth mentioned in class x certificates will be given that particular position.

- Admission: 14.09.2020 to 16.09.2020.
- Publication of selection list of remaining students if seats remain vacant: 18.09.2020.
- Admission: 19.09.2020 to 20.09.2020.
