Rules & Regulations of the Swimming Pool

1. The user of the pool must be a member and a valid card holder and should produce the ID card before entering the premises.
2. The passes and ID cards are not transferrable
3. The user shall sign the entry and exit timings
4. The user will have to produce a medical certificate from a certified medical institute that the user is free from any skin disease or any contagious disease.
5. The user needs to take the permission of the coach/ lifeguard before entering into the pool.
6. Though the coaching facilities will be available the users of the swimming pool will enter the water entirely at their own risk and responsibility
7. The users are not allowed to use the facility beyond the specified times by the authority.
8. The user should arrive at the swimming pool 15 minutes before the time slot allotted to them
9. The users will not be allowed to enter into the swimming pool without the appropriate swimming costumes.
10. Every user must take a shower and footbath before entering into the pool
11. Spitting of any kind is strictly prohibited and will be fined ₹ 500 if found guilty.

12. Use of oil or any other lubricants on the body before entering the pool is strictly prohibited
13. Urinating in the swimming pool is strictly prohibited
14. Shoes are not allowed on the deck
15. Users with long hairs must use swimming cap before entering the swimming pool
16. Parents/ guardians are not allowed to interfere in the coaching related activities
17. In case of emergency the user must draw the attention of the coach/ lifeguard on the deck.
18. The users will be responsible for the safety of their own belongings and the authority will not be responsible for any theft or loss
19. Smoking and drinking is not allowed in the premises. The user must not be drunk before using the swimming pool.
20. Eatables are not allowed inside the premises
21. Pet animals are not allowed in the premises
22. All the fixtures and fittings must be handled with care. Any damage to the govt. property caused by any individual will have to pay the compensation.
23. The authority reserves the right to close the swimming pool for any specific purposes.
24. The management have the right to expel any member for appropriate/ valid reasons
25. The management reserves the right to add/ amend or alter any rules.
26. The batch timings are decided by the management and the management reserves the right to make changes in the timings as per the demand
27. The swimming pool may be closed for the weekly, monthly or yearly maintenance, major repair if any, conducting swimming competitions or for any other specific reason with one day notice.
28. User agrees to provide the right to use and display name, image and biography to Sports & Youth Services Department, Govt. of Odisha in publications, social media channels, promotional and publicity materials throughout the world in connection with Sports & Youth Services Department, Govt. of Odisha
29. Users are expected not to interact, on behalf of Sports & Youth Services Department, Govt. of Odisha, with media representatives or invite media persons on to the facility without the permission of the Officials.
30. Users are not permitted to either audio or video record lectures of any training session or actions of other users, or staff without prior permission
31. Users are not permitted to provide audio and video clippings of any activity on the campus to media without prior permission from the Department Officials
32. Users are expected to use the social media carefully and responsibly.
