NOTICE

In pursuance to the Housing & Urban Development department Letter No 13408/HUD Dt-30.07.19 it has been decided to deploy human resource (referred as SWACHHA SATHI) on fixed term basis at household clusters (for cluster:600 Households for one Swachha Sathi for ward no 02,12,7 & 14) Within Sonepur municipality jurisdiction to facilitate and catalyse viz. door to door waste collection waste segregation at source, user fee collection, function of MMC & MRF through IEC awareness tools.

Eligibility Criteria

- She must be a resident of Sonepur municipality area.
- Must be a member of WSHG/ ALF of Sonepur Municipality
- Nomination of the candidate from the SHG/ALF
- Not having Criminal track records political affiliation
- Having education qualification +2 for Swachha Sathi (However the education qualification may be relaxed in case of non- availability of suitable candidate)
- She should be a good communicator having ability in community mobilization basic managerial skills or prior experiences, which will be assessed (as per SoP on decentralized Solid Waste Management, Para-3 i.e Assessment of Human resources) during shortlisting of prospective applications.

Evaluation of Applicants

Evaluation of applicants using a weighted system(out of 100 marks) that takes into account the following :

- Nomination from SHG/ALF (10%)
- Assessment on waste management (30%)
- In person interview (40)
- Experience in community mobilization (10%)
- Education (10%)

Applicants with the highest combined scores will be called for final selection. The successful candidate will be contacted via Phone/Letter.

Interested Candidates possessing the requisite qualification may apply in proscribed format along with self-attested copies of certificates, one passport size photograph as given below to the undersigned on or before **08.12.2021**. The selected candidates will be briefed and trained about the mandated job requirement by the ULB.


