**Tender Notification No. 2 Dt. 29.05.2023 of DFO, Subarnapur Forest Division**

In view of the typographical error occurred in the Tender Notification No. 2 Dt. 29.05.2023 of DFO, Subarnapur Forest Division, the following changes have been made in the tender documents published vide above Tender Notification of DFO, Subarnapur.

(A) The Planting materials to be procured are revised as follows.

1. N.P.K
2. N.P.K Based Bio-Fertilizer/Organic Manure
3. Vermicompost
4. Insecticides (Chloropyriphos Dust)
5. Neem Cake
6. Fencing materials like
  - (i) HDPE Hexagon Tree Guard: - 1.5 mtr. Height x 1.2 mtr. Girth with UPV having 400 GSM.
  - (ii) Bamboo Gabion: - To be fixed with 4 Round Bamboo re-enforced and rounded by bamboo cut blade. Size 5 Ft Height x 1.5 ft diameter Breadth from wall to wall (6 Ft circumference length) both in Circular or in Square shape as the case may be.
  - (iii) Bamboo Poles: - Specification 7.5 ft length, Dia-40 mm.

(B) All other terms and conditions as published in the Tender Notification No. 2 Dt. 29.05.2023 will remain unchanged.


