## **TERMS & CONDITION**

1. The quotationer should furnish true copies of valid GST clearance certificate/PAN card certificate duly attested along with the quotation paper.
2. Rate should be mentioned both in figure and words.
3. Cost of tender paper Rs.2000/- (Rupees two thousand ) only and EMD of Rs.10,000/- (Rupees Ten thousand) only in shape of demand draft from any scheduled bank in favour of Executive Officer Sonapur Municipality should accompany with the quotation paper which shall be refunded to unsuccessful tenderers in due course. No other payment towards EMD shall be accepted. Quotation received without cost of tender paper , EMD shall be rejected.
4. Any tender received incomplete will be summarily rejected.
5. All documents as per advertisement must be enclosed with the tender schedule otherwise tender will not be taken into consideration.
6. Any legal dispute arising shall be settled under the jurisdiction of Sonapur court & no power of attorney or affidavit shall be allowed.
7. Any deviation of violation to the terms & conditions, the quotation shall be rejected.
8. Before execution of work contractor has to supply the materials for inspection by Municipal Authority.
9. Original materials should be supplied to this office within the stipulated date and time failing which the EMD shall be forfeited without notice.
10. Payment will be made as per availability of funds and after successful completion of the project subject to satisfactory certificate furnished by Municipal Engineer.
11. The material shall be specified as per brands specification only as mentioned in quotation schedule and strictly in accordance with relevant ISI specification. And the price list of specified brand must be submitted with quotation.
12. The guarantee certificate from manufacturer of the above materials must be mentioned in the quotation paper with an under taking that the materials be replaced immediately, if found any defect within the guarantee period. The guarantee period of materials is 1(one) year from the date of supply.
13. Offer received incomplete in any manner will be summarily rejected.
14. Original materials should be supplied to this office within the stipulated date and time, failing with the E.M.D. shall be forfeited without notice.
15. Payment will be made as per the availability of funds and 5% SD money will be deducted from the bill of successful quotationer which will be refunded after completion of guarantee period.

16. The successful quotationer should furnish the manufactured test certificate of the materials.
17. Any other information can be collected from the office of the Executive Officer Subarnapur Municipality, Subarnapur.
18. The approved quotation shall make an agreement on above mentioned term & condition with the Executive Officer, Subarnapur Municipality.
19. The quotationer has to submit their quotation in two main parts i.e. Part-A Technical Bid and Part-B price Bid. The technical bid and price bid must be packed in separate sealed envelopes labeled with the quotation title, quotation call notice no.
20. The technical bid and price bid shall be opened on the above date and time for quotationers qualifying the first opening process of (Part-A), their price bid (Part-B) will be opened. If any shortage in their documents the quotation shall be rejected.
21. Before opening of financial bid, the quotationer has to show a power point presentation of the items installed in similar nature of work. The tender committee, if desired, may ask for physical inspection of such work in which case the quotationer shall have to arrange for such inspection at his own cost. The tender committee reserve the right to reject the quotation if found un-satisfactory. The decision of the tender committee shall be final.
22. After finalization of the tender, the agreement is to be done within 3 days and work is to be executed within 15 day's time period.
23. The firm/ agencies / bidder having quoted lowest price in maximum number of items will be given the opportunity to provide other items at the lowest price .The tender committee reserves the right to award the tender in favour of a single bidder or multiple bidders.
24. The authority reserves the rights to reject any or all the quotations without assigning any reason thereof.
