



Sealed quotation/Tenders are invited from interested reputed Travel Agencies/Tour operators or private individuals for providing one no. of non AC petrol/Diesel driven Tiago/Bolt/Celerio vehicle having seating capacity not more than four including driver for official use in office of the Deputy Director of Textiles, Sonepur on monthly rent basis.

1. The vehicle must be road worthy condition shall not be more than 3 years old from the date of initial registration & must have valid registration certificate, Insurance certificate, fitness certificate, valid contract carriage permit, valid GST registration certificate, valid Gem registration certificate, Proof of up-to-date tax payment etc. which are mandatory for plying of vehicle. Vehicle older than 5years should be replaced by new vehicle by the service provider. In view of pollution being high through use of diesel vehicle it should be BS-IV or above compliant petrol vehicle.
2. The driver of the vehicle must have valid driving license for driving light transport passenger vehicle & should be sufficiently experienced in driving transport passenger vehicle
3. The driver should be well behaved, gentle & obedient in nature.
4. A sum of Rs.5000/- shall be deposited by the intending bidders in shape of account payee bank draft drawn in favour of Deputy Director of Textiles, Sonepur & submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
5. The monthly rate of hire charge be quoted separately in general bid information (excluding fuel, lubricants & GST).
6. The vehicle must achieve a fuel efficiency of minimum 17kms per litre.
7. The details of the make & the year of manufacture of the vehicle registration number, Mileage (kms cover per litre), Name of the driver with driving license no. & period of validity, GST Registration certificate & Gem Registration Certificate should be specifically provided in the general bid information to be furnished with the quotation/tender (Annexure-III).

TERMS & CONDITIONS FOR HIRING OF VEHICLES

The following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on hire on monthly rent basis.

1. The hired vehicles during period of contact, shall have all necessary valid MV documents such as :- Valid registration certificate, Insurance Certificate, Fitness Certificate, Valid Contract Carriage Permit, proof of up to date tax payment etc. and D.L of the driver available all the times .The department/office hiring the vehicle shall not be responsible for any damage/loss caused to hired vehicles or loss of life/injury made to any person or damage to any property on account of use of hired vehicle any manner whatsoever . The hirer shall be responsible for all such litigation.
2. The service provider should have valid GST registration & GEM registration.
3. The hire charges to be paid for monthly basis is final and does not include cost of fuel (Diesel/Petrol) which is to be paid separately basing on actual consumption and lubricants as per existing Govt. norms. All the expenditure of the vehicle towards repair, replacement of spare parts, lubricating of oil of engine, Gear box and differential Coolant, Tyre & Tubes, Battery etc. will be borne by the bidder.
4. It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the owner.
5. In case of breakdown for reasons whatsoever the replacement of vehicle of the same or better model shall be provided by the owner of the vehicle/ bidder.
6. A sum of Rs. 5000/- shall be deposited by the intending bidder in shape of Account Payee bank draft drawn in favour of Deputy Director of Textiles, Sonepur and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
7. The vehicle must achieve a fuel efficiency of minimum 17 kms.perlitre.
8. In case of vehicle do not report regularly, the authority will be at liberty to reject the agreement and may engage vehicle from other source.
9. The vehicle shall report for duty for minimum of 25 days in a month.
10. In case of emergency the driver will have to report for duty as per requirement of hirer no extra payment shall be demanded.
11. Monthly hire charges and reimbursement towards cost of diesel (as per actual) and lubricants (as per Govt. norms) of selected bidder will be paid in every succeeding month, as far as possible within 15 days of the submission of the bills by the service provider and no advance payment will be made.
12. The vehicle shall not be more than 3 years old from the initial registration and also in good running condition during the period of contract. Vehicles older than 5 years should be replaced by new vehicle by service provider.
13. If the services are found to be unsatisfactory. The client shall give one-month notice and terminate the agreement.
14. In case the service provider intends to withdraw the services of the vehicle and terminate the agreement, it shall be mandatory upon him for grant one-month notice before such withdrawal of service and termination of the agreement.
15. If the bidder violate any of the terms of contract Govt. shall forfeit the entire amount of security deposit.
