TERMS AND CONDITIONS.

Only for the Registered Gas Agencies should apply at the time of quotation.

1. The approved supplier will have to supply the materials in the office of the undersigned within 30 days on receipt of order.
2. No extra charges towards transportation of materials payment will be pade to the Agency.
3. No advance payment will made. After supply of all materials payment will be made only on approved item of good quality through A/C payee Cheque and GST bill submission is mandatory for payments.
4. The supplier will take the responsibility to exchange the refilled Gas cylinder in the AWC point in a regular basis.
5. During the filling of quotation of paper one must be produce sample item to be supplied at the time of opening of quotation. Without production of sample quotation paper will be rejected by the committee.
6. The quotationer or his representative may remain present during opening of the quotation. Otherwise the quotation shall be opened in the scheduled time, absence of any or all quotationers.
7. The quotationers shall have to produce up to date sales tax and income tax clearance certificate issued by the competent authority during opening of the quotation in original. Non production/Submission of the same will entail objection of the Agencies concerned'
