

- 1) Each bidder shall submit only one Expression of interest as per the enclosed Expression of interest format.
- 2) The Bidders are required to deposit non-refundable Expression of interest paper cost Rs.1,000/- (Rupees One Thousand ) only in shape of Demand Draft/ Banker's Cheque in favour of Block Development Officer, Dunguripali Payable at Dunguripali while submitting Bid.
- 3) The bidder should submit and execute a "Bid security Declaration" in lieu of Bid security (EMD) with stipulation that if the bidder withdraws or modifies his bids during period of validity etc., the bidder will be suspended for the time specified as per finance department letter no.8943/F dated 08.03.2021 of Government of Odisha.
- 4) The successful bidder will have to deposit a performance security Deposit of 3% of the contract price in the form of TDR/from any Nationalized/Scheduled Bank drawn in favour of the Block Development Officer, Dunguripali Payable Dunguripali/NSC duly pledged in favour in Bdo Dunguripali covering a period of one (01) year from the date of intimation to the selected bidder with award of supply.

- 7) The bidders are to submit their Expression of interest in separate sealed covered envelope for technical bid and Financial Bid by subscribing "**Technical Bid**" in cover "**A**" and "**Financial Bid**" in cover "**B**" and both covers should be put in third cover "**C**" which should be subscribed as "**Expression of interest for Implementation of Wall Painting in various villages of Dunguripali Block Under SBM-G Phase II**".

- 9) The authorized representative should show authorization letter at the time of opening of technical bid.
- 10) The Financial bid in cover "**B**" will be opened of only those who have technically qualified at **11.00 A.M. on 26.11.2021**.
- 11) The tender shall remain valid for a period of 60 days from the last date fixed for receiving the same.
- 12) Delivery/Completion period will be intimated in the work/delivery order. Failure to supply the goods/ services with in time period the order will be automatically stand cancelled without further communication.
- 13) Rate quoted must be inclusive of all taxes, transportation and installation & will be valid for a period of one year from the date of approval.



