



- 1) Each bidder shall submit only one quotation as per the enclosed Quotation format.
- 2) The Bidders are required to deposit non-refundable Tender paper cost Rs.1,000/- (Rupees One Thousand) only in shape of Demand Draft/ Banker's Cheque in favour of Block Development Officer, Binka Payable at Binka while submitting Bid.
- 3) The bidder should submit and execute a "Bid security Declaration" in lieu of Bid security (EMD) with stipulation that if the bidder withdraws or modifies his bids during period of validity etc., the bidder will be suspended for the time specified as per finance department letter no.8943/F dated 08.03.2021 of Government of Odisha.
- 4) The successful bidder will have to deposit a performance security Deposit of 3% of the contract price in the form of TDR/Bank Guarantees from any Nationalized/Scheduled Bank drawn in favour of the Block Development Officer, Binka Payable at Binka covering a period of one (01) year from the date of intimation to the selected bidder with award of supply.
- 5) The Conditional bids shall not be considered and will be rejected in very fast instance.
- 6) Sealed Tenders will be received up to **02.12.2021** to till **05.00.P.M** in the office of the Block Development Officer, Binka . Any Tender receive after the due date and time will be rejected/ Returned to the sender without opened . The Tenders will be received through regd. Post/ Speed post only.
- 7) The bidders are to submit their tenders in separate sealed covered envelope for technical bid and Financial Bid by subscribing "**Technical Bid**" in cover "**A**" and "**Financial Bid**" in cover "**B**" and both covers should be put in third cover "**C**" which should be subscribed as "**Tender for Implementation of Wall Painting in various villages of Binka Block Under SBM-G Phase II**".
- 8) The sealed tender cover "**A**" (Technical Bid) submitted by the tender will be opened by the purchase committee in the conference hall of Binka Block on **04.12.2021** at **11.00AM**. The bidder or his representative may present at the time of opening of the tender.
- 9) The authorized representative should show authorization letter at the time of opening of technical bid.
- 10) The Financial bid in cover "**B**" will be opened of only those who have technically qualified at **11.30 A.M. on 04.12.2021**.
- 11) The tender shall remain valid for a period of 60 days from the last date fixed for receiving the same.
- 12) Delivery/Completion period will be intimated in the work/delivery order. Failure to supply the goods/ services within time period the order will be automatically stand cancelled without further communication.
- 13) Rate quoted must be inclusive of all taxes, transportation and installation & will be valid for a period of one year from the date of approval.

14) The under signed reserves the right to place the order in phases.

15) The numbers of items/materials are subject to change in supply order as per requirement.

16) Any effort by a bidder to influence the purchaser in its decision on bid evaluation or placement of supply or purchase order may result in rejection of the bidder's offer.

17) If the stocks supplied by the successful bidder does not match with the specification as per Tender Document at time of delivery of items then the stocks will be rejected & the supplier has to replace the total quantity of the same product of his own cost.

18) The Purchaser will evaluate and compare the quotations determined to be substantially responsive i.e. which (a) are properly signed and (b) confirm to the items & condition and specification.

19) In case where two or more bidders have quoted the exact same price then the winner will be decided by a transparent lottery to be held right after the opening of the Financial Bid is completed.

20) If found that the successfully bidder is incompetent to provide the supply of service/materials, in such a situation, the proposal may be reviewed for award of the contract to the next qualifying bidder or go for a fresh bid depending on the circumstances. No form of compensation shall be payable in any from whatsoever to the forfeited firm. In case it decides to go for the next qualifying bidder, negotiation may consider to bring down their price nearer to the originally Evaluated or Lowest bidder in consideration to the orders to be supplied.

21) The bidder should deliver and install the goods (where ever applicable) within such time as per purchase order. The bidder should take responsibility of the goods till it reaches the delivery destination. Insurance etc. shall be arranged by the supplier. Supplier shall arrange the road permits or any other document wherever required.

22) The warranty (if applicable) shall be on-site, comprehensive for a period of minimum three years from the date of installation.

23) The successfully bidder shall not assign or sub-contract or sub-let the whole or any part of the supply order or any manner.





