3. The highest tenderer, whose tender will be accepted, shall deposit 25% of the offered amount on 01.12.2021 as initial deposit. After the sale is confirmed, the balance amount shall be deposited by successful bidder within 7 days of the date of confirmation of the bid and subsequent communication failing which initial deposit and earnest money shall be forfeited.
4. The successful bidder shall remove the vehicle from the campus of Panchayat Bhawan, Subarnapur within 7 days after payment of total bid amount as mentioned above. Failure to remove the vehicle within stipulated time before 09.12.2021 tender shall be cancelled and amount deposited by successful bidder shall be forfeited.


