5. Indent will place to the successful bidder and materials should be supplied to the undersigned within 15 days time from the date of receipt of indent.
6. The bidder should show the sample on the opening day of the tender before the purchase committee.
7. The supplier should attach the GSTIN clearance certificate and ID proof with tender.

The application form of tender will be available with JFDO of the CDVO office Subarnapur on payment of Rs.200/- (Rupees two hundred) only Non refundable + GST @ 12% in total Rs.224 from dt.02.12.2021 to 08.12.2021 up to 5.00 P.M. or can be downloaded from Odisha Govt. website www.subarnapur.nic.in from dt.02.12.2021. In case the application form is downloaded from Govt. website, the applicant shall furnish a Demand Draft for an amount Rs.224.00 (Rupees two hundred twenty four) only including 12% GST Non refundable towards the cost of tender application form.
