

In suppression of Tender Call Notice published vide Bid Identification No. 01/2021-22, Dtd. 13.11.2021 of Divisional Forest Officer, Subarnapur Forest Division on behalf of the Governor of Odisha duly cancelled vide Memo No. 5758, Dtd. 03.12.2021 owing to technical disruption once again DFO, Subarnapur Division on behalf of the Governor of Odisha invites **Percentage basis bid, in Single Cover System**, only in "ON LINE" mode for construction of Building works detailed in the table below, from eligible "**C & D**" class contractors registered with the State Government and contractors of **equivalent** grade/class registered with Central Government / M.E.S. / Railways or other Licensing Authorities for execution of Civil & P.H works on production of definite proof from the appropriate authority.

2. The bidder shall have to transfer the cost of tender paper "ON LINE" for the amount as specified for the work in the table **Col 5** above as part of bidding through a process as mentioned in the DTCN.
3. The bidder shall have to upload the bid security declaration as specified for the work in the table **Col 4** above as part of bidding through a process as mentioned in the DTCN.
4. The Bid documents will be available in the website: www.tendersodisha.gov.in from **10.12.2021 to 20.12.2021 up to 5.00 P.M for online bidding**.
5. The bidders must possess compatible Digital Signature Certificate (DSC) of Class-II or Class-III.
6. Bids shall be received "ON LINE" on or before **5.00 PM of dt 20.12.2021**.
7. Bids received online shall be opened at **11.30 hours on 21.12.2021** in the Office of undersigned in the presence of the bidders who wish to attend. Bidders who participate in the bid can witness the opening of bids after logging on to the site through their DSC, If the office happens to be closed on the last date of opening of the bids as specified the bids will be opened on the next working day at the same time and venue.
8. In case the bidder intended to quote less price than the amount put to tender shall be abide by the Govt order **No. 4559 dt. 05.04.2021** i.e. amendment to Para-3.5 (v) of OPWD Code, Vol-I with modification that "**Additional Performance Security** shall be deposited within 7 days of the issue of letter of acceptance by failing which the bid shall be cancelled and the security deposit shall be forfeited. Further, proceeding for blacklisting shall be initiated against bidder.
9. Bidders are to submit only the original BoQ uploaded by Publisher after entering the relevant fields without any alteration / deletion / modification multiple BoQ submission shall lead to cancellation of bid.
10. As it is a percentage rate tender, the bidders quoting zero value is valid and will be taken as schedule of rates.
11. The Authority will not be held responsible for any technical sang or network failure during online bidding
12. Other details can be seen in the bidding documents.
13. The authority reserves the right to cancel any or all bids without assigning any reason thereof.
14. The Addendum/Corrigendum if any will be hosted in the website only.
15. The intending bidders are required to furnish their e-mail address and cell phone number to inform them any message relating to the tender
