5. The bidder will have to make a performance security Deposit of 3% of the contract price in the form of Bank Guarantee from any nationalized bank drawn in favour of the BDO, Dunguripali covering a period of one year from the date of intimation to the selected bidder with award of supply.

6. The specification as mentioned in the notice inviting expression of interest must be followed by the bidders.
7. The bidder should supply materials as per specification in the expression of interest. If the stock supplied by the bidder does not match with the specification, the stock will be rejected and the supplier has to replace the total quantity of the same product at his own cost.
8. The bidder shall not assign or sub-contract or sub-let the whole or any part of the work order in any manner.
9. The bidder should take responsibility of the materials till it reaches the delivery destination. Insurance etc. shall be borne by the supplier. Bidder shall arrange the road permits or any other documents wherever required.
10. The bidders are required to submit EMD of Rs.10,000/- in shape of TDR/NSC duly pledged in favour of BDO, Dunguripali. The EMD of the unsuccessful bidder will be return soon after completion of bidding process.


