AUCTION SALE NOTICE FOR DISPOSAL OF OUT OF SERVICE EMAS AMBULANCES (108)

Sealed tenders are invited for disposal of condemned EMAS Ambulances lying at different locations of Subarnapur district. Intending bidders may obtain Tender paper containing Terms & Condition, details of vehicles and its location in the district NIC website i.e. [www.Subarnapur.nic.in](http://www.Subarnapur.nic.in). Also they may inspect the said ambulances to be disposed-off in 'as is where is conditions" on any working day during office hours at the designated locations. The sealed tender papers to be submitted to the CDM & PHO, Subarnapur on or before 10/05/2022 through Regd post/Speed post/Courier only up to 5PM and the same will be opened on the next day i.e. 11/05/2022 at 11. AM.

The Bidder of his Authorized representative may remain present at the time of opening of the sealed Tender as per the above schedule programme. **Annexure-2** will be submitted by the bidder to authorize his representative to attend the bidding process.

The authority reserves the right to accept or cancel any or all tenders without assigning any reason thereof.

**Terms & Conditions for disposal of condemned EMAS Ambulances (108) through Auction Sale Notice.**


- Condemned Ambulances are to be disposed-off along with location as annexed in Annexure 3.
- The participants may inspect the ambulances at places/location mentioned against each on as is where basis in the premises during the office hours with permission from the CDM & PHO, Subarnapur/Superintendent of the DHH/SDH/CHCs.
- Ambulances will be auctioned in "as is where basis".
- The terms, conditions and guidelines for Bidders should not be submitted with the TENDER FORM. Only filled up the tender form should be submitted.
- Tender shall be submitted in " TENDER FORM" Annexure-1
- Any mistake noticed in the Tender Form will be decided by the Tender screening committee and its decision will be final.
- The bidders shall quote the rate visibly in words (Block letters & Numerical) to avoid confusion.
- The Tender paper shall be submitted in sealed cover superscribed "TENDER FOR DISPOSAL OF CONDEMNED AMBULANCES (108)". Also mentioning detail address on the left side of the cover with their Telephone No/Mobile no. etc.
- All Bidders shall submit the Tender by Register post/Speed post/Courier only.

- Tender will be opened on the stipulated Date & time by the constituted Tender screening committee comprising of the following district level officers.

- Intending bidders shall have to enclose a Bank draft/Banker cheque of Rs. 2, 500/- (Rupees Two thousand Five hundred only) as Bid Amount (EMD) *for each vehicle* for which bid is submitted which is non refundable and the same will be submitted along with Tender Form. This will be drawn in State Bank of India, SUBARNAPUR or any Nationalize Banks in favour of Non-NRHM Account ZSS, O/O Chief District Medical & Public Health Officer, Subarnapur and should be submitted along with the tender paper failing which the tender will not be accepted.
- The bidders are required to submit photocopy of PAN card/Adhar Card/Voter Id/Pass Port along with the sealed bid.
- Non submission of any documents leads to automatic cancellation of participation in the auction process and the cost will be forfeited.
- No undertaking for submission of documents is allowed
- The bidder quoting highest price approved by the authority will be asked to deposit 25% of the quoted rate immediately on confirmation of acceptance of tender and the rest amount of 75% should be deposited within 7 (Seven) days through Demand Draft/Bank Draft from any nationalized bank in favour of CDM & PHO, SUBARNAPUR. In case of failure to pay the amount, the deposited amount will be forfeited and the vehicle will be offered to the bidder quoting next highest rate.
- On payment of total amount clearance will be issued by the CDM & PHO, SUBARNAPUR
- No dispose-off value will be accepted without the presence of the successful bidder or their Authorized agents.
- The Condemned Ambulances will be handover to the successful bidder on receipt of full payment of the accepted Disposed-off value within 7 days of the approval of the offer.
- Tool Implements and spare parts shall not be delivered R.C Books etc which are not available shall not be delivered along with the ambulances
- The tenderer will remove the vehicle from the site within 7 (Seven) days of payment of money in full. The safeguard and custody of the vehicle shall be responsibility of the tenderer. No claim or complaint in this regard shall be entertained by the undersigned.
- In case of dispute or any matter the interpretation & discussion of the authority shall be final & binding and the legal procedures if any should be in the jurisdiction of SUBARNAPUR district.


