


# 1. Notice inviting proposal



3. **The quoted price must be computerized & over writhing of price will lead to rejection of the tender.**
4. The bidder has to deposit the EMD for an amount of **Rs 5000/-** (Rupees five thousand only) in form of demand draft in favour of **ROGI KALIAN SAMITI, DHH, SUBARNAPUR, Payable at SBI, Subarnapur (1085) along with the tender.**




