TENDER CALL NOTICE

Sealed Tenders are invited from the interested firms for procurement of under stated items under the terms and conditions mentioned below for the financial 2018-19. The tender should reach to this office on or before dt. 14.12.2018 at 01.00.PM. failing which the tender will not be entertained and will be opened on the same day at 03.30 P.M. in the office of the undersigned. The tenderer or his representative may be present at the time of opening the tender.

Terms & Conditions

1. Specification of the spectacles:-
 - a. Frame – Acetate (different colour).
 - b. Lenses – White English.
2. The spectacles proved by supplier will be free air bubbles, scratches, waves & irregular shape and carry 3 months warranty for repair & replacement for any manufacturing/ fitting defects (eg. Loose hinges) would be free of cost.
3. The required spectacle would be provided within 15 days of receiving of the order. The supplier is expected to keep enough stocks of the frame (of different sizes & colours) and the lenses to ensure timely supply of the spectacles to the children.
4. The supplier has to attend the D.B.C.S., Subarnapur to obtain the order for supply.
5. If the above specifications are not adhered to, or the child has been provided wrong lenses, as found later by the Ophthalmic Assistant/ Eye Specialist, the concerned Supplier will not be entitled to receive any payment for such spectacles. He will be asked to provide free replacement if payment was already received. If this happens too often, the Society can terminate the contract with the concerned supplier even before the stipulated expiry of its period.
6. The authorization will be valid for a period of one year from the date of signing of the agreements.
7. The firm should furnish their tender along with copies of the registration of the firm, PAN card, sale tax clearance certificate/ income tax return 2017-18/license of GST /GST clearance etc.
8. The bidder have to submit an **EMD of Rs.10000/- (Ten thousand only) and Rs.500/- (Five Hundred)** towards Security Deposit (Refundable) and Paper Cost (Non-Refundable) respectively in shape of Demand Draft separately in favour of ZSS (NPCB), Sonapur, Ac/No.11404542503, payable at SBI Sonapur. The EMD will be refunded to unsuccessful bidder within 10 days of finalization of the tender without any interest. The EMD will be converted to Security Deposit in case of successful bidder and will be refunded without any interest within 2 months from the date of the completion of contract period.
9. Selection of the supplier / firm would be made by the committee considering both the cost and quality.
10. Supply should be according to the specification.
11. Price escalation would not be entertained after approval of the tender.
12. The undersigned reserves the right to accept / reject any or all rates quoted without assigning any reason thereof to the firm.
13. The separate sealed envelope must be super scribed as "Quotation for Financial Bid" for financial bid and "Quotation for Technical Bid" for technical bid to be kept in a separate envelope super-scribed with "ITEMS OF DBCS PURCHASE".
