TERM & CONDITION FOR BPMU VEHICLE

1. A contact of engagement must be entered into with the travel agency/individual/private organization /NGOs etc. and the MO I/C CHC Dunguripali.
2. The Vehicle must be a multi utility vehicle .Preference will be given to Bolero,Scorpio and vehicle of less than 2 years old.
3. The initial contact period will be 12 month or till the Closure of the Mission whichever is earlier.
4. The vehicle to be engaged should not belong to any employee of NHM, MO I/C CHC Dunguripali, any health department employee of the close relative of the employee of NHM.
5. All the major and minor repair should be made by the vehicle owner himself.
6. The vehicle must be available with BPMU office on all working days &Holidays as desire by MO I/C CHC Dunguripali for office purpose only.
7. The vehicle should not be spread for private use of any official of BPMU office.
- 8.The record of vehicle usage and log book will be maintained by the second party ,and should be counter signed by the concern members of MO I/C on a daily basis .The extract of such documents should be produces to the first party along with the bill.
9. The second party will be responsible for payment of Road Tax, Compressive insurance of the vehicle.
10. DOL will be provided by the BPMU as per norms of 12Km per liter .No cost of engine oil or other consumable will be provided from the first party.
11. The Bidder have to submit an EMD of Rs5000/- (Five thousand) in shape of Demand Draft separately in favour of RKS CHC Dunguripali payable at Dunguripali .The EMD will be converted to security deposit in case of successful bidder and will be refunded without any interest within 2 month the date of the completion of contact period of disengagement of the vehicle.
