

TERM & CONDITION

1. The rate quoted should be in Indian Rupees and inclusive of all taxes.
2. Interested firms/Agency, etc. to file two sealed cover i.e. one containing **Technical bid** in prescribed format and 2nd **Financial bid** in prescribed format. The sealed cover must be marked as "**Technical bid**" and "**Financial bid**". First Technical bid will be opened and evaluated by the committee and the successful quotation in Technical bid, their financial bid will be taken into account.
3. During the contract period 4 (Four) mandatory services will be provided i.e. one each in every three month.
4. In case of exigency beyond the mandatory service, the service provider shall attain within seven days to serve on call. In such case no transportation and incidental expenses will be borne by the Customer.
5. Two sets of consumables appliances/items will be provided free of cost per year during the mandatory services (**Dishcare IDW Detergent-20 Ltrs and Dishquick-5 Ltrs two times for Dish Washer and two candles & Carbon black for water purifier**) by the firms.
6. The Customer will retain the defective/replaced spares and the cost of new parts required, if any, will be borne by the Customer.
7. In no case the service provider will assign/entrust the task to other partner or Agency.
8. Validity of the contract will commence from the date of issue of assignment/order and the service provider will have to give service till completion on one year from the date of issue of assignment/order.
9. Any legal dispute arising out of this are subject to jurisdiction of Sonapur only.
