Sealed quotations/tenders are invited from interested vehicle owners/travel agencies/tour operators for providing one no. Of Bolero Non AC/AC Diesel/ BS-VI Compliant Petrol Vehicles driven vehicle having sitting capacity not more than ten including driver, which shall conform to the terms and conditions(Annexure-II) for official use in Tahasil Office, Sonepur during the period 1.06.2020 to 31.03.2021.

- 1.The Vehicle must be in roadworthy condition, shall not be more than three year old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, Valid Contract Carriage Permit, Proof of up to date tax payment etc. Which are mandatory for plying of vehicle.
- 2.The monthly rate of hire charges be quoted separately in the general bid information(excluding fuel and lubricants)
- 3.The Vehicle must achieve a fuel efficiency of 10 KMs per litre.
- 4.The details of the make and year of manufacture of the vehicle, registration no.,mileage (KMs covered per litre) and name of Driver with Driving License No. And period of validity should be specifically provided in the general bid information to be furnished with the quotation/ Tender(Annexure III).
- 5.The Driver of the vehicle must have valid Driving license for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
6. The Driver should be well behaved, gentle and obedient.
- 7.The Salary of the Driver, Repair and maintenance cost, taxes, insurance cost etc. Shall be borne by the Vehicle Owner.
- 8.Intending Owner/ Travel agency must quote the rate of consumption of fuel in the quotation.
9. Monthly hiring charges and rate of consumption of fuel shall be considered for acceptance of quotation subject to fulfilling other terms and conditions of tender.
- 10.The interested parties are requested to apply with detailed of the vehicle such as Model of Vehicle, Registration No., Permit No., Period and Tax Paid, Insurance coverage(Attested Xerox copies must be attached with the quotation.
11. A sum of Rs.5000/- shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the Tahasildar, Sonepur submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
- 12.The Vehicle Owner of the accepted quotation shall have to sign an agreement with the undersigned in non-judicial stamp paper before placing the vehicle into Government Service within a week of finalisation of quotation.
- 13.In case of violation of agreement by the vehicle owner or any difficulty experienced by the undersigned in getting service/ use of vehicle, the vehicle shall be disengaged from the service without assigning any reason thereof.

14. The monthly charges of the vehicle will be paid to the vehicle owner subject to availability of Govt. Allotment on MV head.

15. The application form of quotation/ tender containing General Bid information, Terms and conditions for hiring of vehicles etc. Will be available at Tahasil Office, Sonapur on payment of Rs.100/- from 7.00 AM to 1.00 PM from 12.05.2020 to 27.05.2020 in Nizarat Section.

16. Quotation can be dropped at the Tender Box available at Tahasil Office, Sonapur. However, the quotation may be sent through registered post along with prescribed documents addressing inscribed on the envelop "Tender for Vehicle".

17. The last date for receipt of quotation in the office of undersigned is upto 27.05.2020 09.00 AM and the date of opening and finalisation of quotation on the same date at 10.00 AM. No quotation will be received beyond stipulated time and date.
