2. The quotations shall be received by the DSWO, Subarnapur or any officer authorized by her till 2.00 P.M of 24.07.20 and will be opened on 24.07.20 at 4.00 P.M. The Tenderer or his authorized representative will present with a sample during the time of opening of quotation.
