Reopening of auction call notice for approximately total 70,539 kg of unserviceable spare parts of Tube well is to be held in the Conference hall of the Panchyat Samiti, Sonepur on dt.21.08.2020. The materials consists 32mm riser pipes, 12mm connecting rods, Head Ass, Handle Ass, Water Chamber, Cylinder body, Third plate, Front cover, Stand Ass and 65mm pipe which are generally used in tube wells. The interested bidders are to attend the open auction which is to be held in the conference hall of Sonepur Panchyat Samiti on the said date at 11.30 A.M.

Terms and conditions of the auction process.

1. The upset price of the unserviceable spare parts are fixed by the Executive Engineer, RWS&S, Sonepur vide letter No.3507 dt.28.07.2020 as Rs.20/- (Rupees Twenty) only per kg.
2. The interested bidders participating in the auction have to deposit a Security amount of Rs.1,50,000/- (One lakhs fifty thousand) only in shape of cash in the office from 10 A.M. to 11 A.M. before the auction starts otherwise they will not be entitled to take part in the auction process.
3. The successful bidder has to deposit an additional amount equal to 15 % of the bidding amount (in cash) as earnest money immediately after the auction process is over.
3. The security deposit of all the bidders except the successful bidders will be refunded by cash after the auction process is over.

The successful bidder has to shift-off the materials from the store within 7 (seven) days at his own risk by weighing the materials after depositing the requisite amount in the TFC bank account No.519110210000001, BOI, Sonepur, IFSC Code-BKID0005191 failing which his security amount will be forfeited.
