3. The Bids will be opened on the Dt. 23.02.2024 at 11.00 AM in the office of the undersigned, in the presence of the members of tender committee of Panchayat Samiti, Ullunda, bidders or their authorized agents who wish to attend at the Conference hall of Panchayat Samiti, Ullunda. If the office happens to be closed on the last date of receipt/ opening as specified, the bids will be received / opened in the next working day at the same time and venue specified in the notification. Other details can be seen in the bidding documents.
4. The companies or individuals registered with State Government and contractors of equivalent Grade / class registered with Central Government / MES having registration for Civil Works having both legal competency and expertise in Civil Engineering works need put tenders for this work and the documentary evidence under appropriate Act.
5. The contract will be drawn in P.W.D. P1 contract Form.
6. No tenderers will be permitted to furnish their tender in their own manuscript papers. No letter should accompany the tender.
7. The tender should be strictly in accordance with the provisions as mentioned in the tender schedule. Any change in the wordings will not be accepted.
8. The work is to be completed in all respects as per NIT Col No. 8 from the date of issue of work order. Tenderer whose tender is accepted must submit a program of work immediately after issue of work order for approval of Engineer-in-Charge.

9. All tenders received will remain valid for a period of 90 days from the last date prescribed for receipt of tenders and validity of tenders can also be extended if agreed by the tenderers and the Department.
10. In case of Engineering contractors seeking exemption of EMD are instructed to enclose an affidavit regarding the list of works awarded during the current financial year with exemption of EMD along with an application to avail the same for this work and will submit copy of original contract license and produce the original license at the time of opening of tender, otherwise the tender will be rejected.
11. Bidders shall provide their e-mail id, correspondence address, Mobile No. (What's App) along with scan copy of valid GSTIN, PAN, and other documents as per DTCN Clause
12. The authority will not be held responsible for any technical problem / failure of Network, Server during the schedule dates of online bidding
