

Interested bidders may submit their sealed quotation in the prescribed format super scribing on the cover of the envelope "**Application for hiring of Vehicle**" to office of the Divisional Labour Commissioner, Subarnapur, At/Po/Ps.- Sonapur, Dist.-Subarnapur, PIN-767017 latest by **27.06.2024 up to 1.00 P.M.** The bids will be opened on the day at 3.30. P.M, The authority reserves all rights to cancel the tender without assigning any reason thereof.

TERMS & CONDITIONS

1. The vehicle must be in road worthy conditions, shall not be more than three years old from the date of initial registration and must have valid registration certificate. Insurance certificate, fitness certificate, valid contract carriage permit, proof of up to date tax payment etc. Which are mandatory or plying of vehicle.
2. The driver of the vehicle must have a valid driving license for driving light transport passengers vehicle and should be sufficiently experienced in driving transport passenger vehicle.
3. It shall be the responsibility of the bidder to provide a good driver (well behaved, gentle and obedient in nature) and the salary of the driver shall be borne by the owner.
4. In case of breakdown for reason whatsoever the replacement of a vehicle of the same of better model shall be provided by the owner of the vehicle/bidder.
5. In case of the vehicle do not report regularly, the authority will be a liberty to reject the agreement and may engage vehicle from other source.
6. The vehicles shall report for duty for minimum of 25 days in a month.
7. In case of emergency, the driver will have to report for duty as per the requirement of hirer. No extra payment shall be demanded.
8. If the services are found to be unsatisfactory, the client shall give one month notice and terminate the agreement.
9. The monthly rate of hire charge be quoted separately in the general bid information(excluding fuel and lubricants)
10. The vehicle must achieve a fuel efficiency of 14 KMPL.
11. The details of the make and year of manufacture of the vehicle registration no. mileage, (Kms covered per liter) and name of the driver with driving license no .and period of validity should be specifically provided in the general bid information to be furnished with the quotation in specific format prescribed which are attached in Annexure-A
12. The quotation completed in all respect should reach the undersigned on or before **27.06.2024 up to 1.00 P.M**
