Sealed Quotations are invited from interested reputed Travel Agencies/Tour operators or Private individuals having valid GST registration (supplier or service) for providing one number of Diesel/ Petrol vehicles(TUV300/Bolero/Sumo/Gold) including driver in concurrence to Finance department Notification No 30464 Dt- 06.09.2019 which shall conform to the Term and Condition for official use in ICDS Project, Birmaharajpur Dist-Subarnapur . On monthly hiring basis in minimum charges of Rs. 25,000/- (Twenty five thousand)only with minimum average of 10 K.M. Per liter vide Finance Department Memorandum No. 30464 Dt- 06.09.2019 and letter no. 0039-2020/ 3854 dt 23.02.2024 of W&CD Department, Odisha.

1. The vehicle must be in Road Worthy condition, shall not be more than One years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate valid Contact Carriage Permit proof of up to date tax payment etc. which are mandatory for plying of vehicle.
2. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
3. The Driver should be well behaved, gentle and obedient in nature.
4. A sum of Rs.10,000/- shall be deposited by the intending bidders in shape of Account payee Bank draft drawn in favour of the C.D.P.O., Birmaharajpur and submitted along with the tender as security deposit. After completion of the tender process. The amount will be refunded to unsuccessful bidders.
5. The monthly rate of hire charge be quoted separately in the general bid information(excluding fuel and lubricants)
6. The Vehicle must achieve a fuel efficiency of 10 KMs per Liter.
7. The details of the make and year of manufacture of the vehicle ,registration no. mileage (KMs covered per liter and name of the driver with driving license No. and period of validity should be specifically provided in the general bid information to be furnished with the Quotation/Tender in prescribed form.
8. The quotation completed in all respect should reach the undersigned on or before Dt. 30.07.2024 by 05.00 PM and shall be opened on Dt-31.07.2024 at 11.00 AM at in presence of the bidders or their authorized representatives in the office chamber of CDPO, Birmaharajpur .

available with Subarnapur Dist. Portal and ICDS Project, Birmaharajpur. The applicant shall furnish a demand draft for an amount of Rs.100/- (one hundred) only in favour of CDPO, Birmaharajpur along with the application.

TERMS AND CONDITIONS OF HIRING OF VEHICLE

The Following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on hire on monthly rent basis.

1. The vehicle must be in Road Worthy condition, shall not be more than One years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate valid Contact Carriage Permit proof of up to date tax payment etc. which are mandatory for applying of Tender.
2. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
3. The Driver should be well behaved, gentle, dressed in neat and clean attire and obedient in nature.
4. A sum of Rs. 100/- (Rupees One hundred)only shall be deposited in shape of Bank Draft towards Tender paper cost and Rs. 10,000/-(Rupees Ten Thousand)only towards EMD by the intending bidders. Bank draft to be drawn in favour of Child Development Project Officer, Birmaharajpur and should be submitted along with the tender paper towards cost of tender . Tender paper cost in non-refundable and EMD will be returned to the unsuccessful bidders.
5. All the expenditure of the vehicle towards repair, replacement of spare parts, Lubricating oil of Engine, Gear Box & differential coolant. Tyers & Tubes, Battery , payment of Insurance/ Road Tax etc. will be borne by the bidder.
