### Important point for Bidders :

3. For providing smooth sanitation services, the Tender Committee has decided that, each bidder must quote their service charges which must not be less than 3.85% of the total estimated cost, unless their bid shall be rejected.
4. The bidder must quote his rate up to two digits after decimal.
5. In the financial bid, the bidder having lowest quoted price shall be awarded the contract. However, in the case two bidders quote the same lowest price, the bidder having highest marks in the technical bid and their past performance shall be awarded the contract.
6. Preference shall be given to the bidder having experience in Installation, Operation & Maintenance of SWM Plant in any Municipalities/ ULBs/PSUs.
