2. **Demand Draft for an amount Rs. 500/- (Rupees Five hundred)** only in shape of Account Payee Bank draft drawn in favour of **District Sports Officer, Subarnapur payable at Sonepur** to be submitted along with the tender as tender paper cost.

7. Quotation received after due date and time will not be accepted.

The quotations should be sent in Sealed Cover addressed to The District Sports Officer, Subarnapur, -767017. **Separate envelops should be submitted for Financial & Technical bids.** The words "supply of Sports equipments" of Subarnapur District - PIN-767017 should be prominently written on the envelope containing the quotation.
9. The firm/ bidder must have Valid GST registration & Pan Card and income Tax Return details for 3 years i.e Financial Year 2021-22, 2022-23 & 2023-24.
10. Only one representative for each bidder shall be allowed to witness the opening of bids. The representative must produce suitable authorization in this regard to be eligible to witness the bid opening on behalf of the bidders. Bidder's representative who are present shall signed in the register evidencing their attendance.
11. The Technical bids will be opened first and successfully completed technical bidders will eligible to take part in the financial bids.
12. Works experience Certificate from authorized Offices / copy of work order in support of execution of similar nature of work in nearby district of Govt Organisation in last three years.
13. The documents submitted by bidders shall be self-attested or else liable for rejection.
14. In case submitted documents are found not genuine on complaint the bidder will liable for rejection at any time.
