

5. All articles should be supplied as per the sample given and selection thereof failing which the supply orders will be cancelled automatically.
6. The rate of the articles should be quoted including all taxes.
7. Copy of GST clearance should be accompanied along with the quotation.
8. Payment will be made in shape of Bank Draft / RTGS/ Account deposit through Treasury Bill after receipt of the articles as per the sample.




