

Tender Call Notice

Sealed Quotations are invited from interested reputed Travel Agencies/Tour operators or Private individuals having valid GST registration (supplier or service) for providing one number of Diesel/ Petrol vehicles(TUV300/Bolero/Sumo Gold/ Ertiga) including driver in concurrence to Finance department Notification No 30464 Dt- 06.09.2019 which shall conform to the Term and Condition Annexure-A for official use in ICDS Project, Ullunda Dist- Subarnapur . On monthly hiring basis in maximum charges of Rs. 25,000/- (Twenty five thousand)only with minimum average of 10km Per liter .

1. The vehicle must be in Road Worthy condition, shall not be more than **Three years old** from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, pollution certificate, Fitness Certificate valid Contact Carriage Permit proof of up to date tax payment, valid taxi permit and valid GSTIN registered etc. which are mandatory for plying of vehicle. The applicant should enclose the self attested photo copy of all document which will be verified at the time of opening of tender.
2. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
3. The Driver should be well behaved, gentle and obedient in nature.
4. A sum of Rs.5,000/- shall be deposited by the intending bidders in shape of Account payee Bank draft drawn in favour of the C.D.P.O., Ullunda and submitted along with the tender as security deposit. After completion of the tender process. The amount will be refunded to unsuccessful bidders.
5. The monthly rate of hire charge be quoted separately in the general bid information(excluding fuel)
6. The Vehicle must achieve a fuel efficiency of 10 KMs per Liter.
7. The details of the make and year of manufacture of the vehicle ,registration no. mileage (KMs covered per liter and name of the driver with driving license No. and period of validity should be specifically provided in the general bid information to be furnished with the Quotation/Tender in prescribed form.(Annexure-B)
8. The quotation completed in all respect should reach the undersigned on or before Dt. **16.06.2025** by 01.00 PM by register post/speed post/ in person and shall be opened on Dt-16.06.2025 at 03.00 PM ~~at~~ in presence of the bidders or their authorized representatives in the office chamber of CDPO, Ullunda.

9. The application form of Quotation /Tender containing General Bid information and terms and conditions for Hiring of Vehicle etc. will be available with Subarnapur Dist. Website(www.subarnapur.nic.in) and ICDS Project, Ullunda .





TERMS AND CONDITIONS FOR HIRING OF VEHICLES

The following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on hire on monthly rent basis.

1. The hired vehicles, during period of contract, shall have necessary valid MV documents such as valid Registration Certificate, Insurance Certificate, Pollution certificate Fitness certificate, valid Contract carriage Permit, proof of up to date tax payment, valid Taxi permit, valid GSTIN registration etc. and D.L. of the driver available all the times. The Department/ Office hiring the vehicle shall not be responsible for any damage /loss caused to hired vehicles or loss of life / injury made to any person or damage to any property on account of use of hired vehicle any manner whatsoever. The hirer shall be responsible for all such litigation.
2. The hire charges per month shall be quoted inclusive of G.S.T but exclusive Fuel cost.
3. The hire charges to be paid for monthly basis is final but does not include cost of fuel, which is to be paid separately basing on actual consumption as per existing Government norms. All the expenditure of the vehicle towards repair, replacement of spare parts, Lubricating oil of Engine, Gear Box and differential Coolant, Tyres & Tubes, Battery etc. will be borne by the bidder.
4. It shall be responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the owner.
5. In case of breakdown for reasons whatsoever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle/bidder.
6. In case of the vehicle do not report regularly, the authority will be at liberty to cancel the agreement and may engage vehicle from other source.
7. The vehicles shall report for duty for minimum of 25 days in a month.
8. In case of emergency, the driver will have to report for duty as per the requirement of hirer. No extra payment shall be demanded.
9. The vehicle shall not be more than **3 years old** from the initial registration and also in good running condition during the period of contract.
10. If any irregularity or financial dispute is pending against the tenderer/service provider previously; they will be debarred from the tender process.
11. If the services are found to be unsatisfactory, the client shall give one month notice and terminate the agreement.
12. The sealed envelope should be super scribed as Expression of Interest for Engagemnt of vehicle on hiring basis in CDPO,Office Ullunda.
13. In case the service provider intends to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon him to grant one month notice before such withdrawal of Service and termination of agreement.
14. If the bidder violates any of the terms of contract, Government shall forfeit the entire amount of security deposit.
