**NOTICE FOR OPEN AUCTION**




### Terms & Conditions of the Auction Process

3. Interested bidders participating in the auction have to deposit a security amount of Rs.30000 (Rupees Thirty thousand only) in shape of B.D.O Binika before the auction starts otherwise they will not be entitled to take part in the auction process.
4. The security deposit of all the bidders except the successful bidders will be refunded after the auction process is over.
5. The successful bidder is required to deposit an amount together with security money amounting to 25 % of bid value within 24 hours towards EMD .Failing deposit of EMD his security amount will be forfeited .
6. The successful bidder has to shift-off the materials from the store within 7 working days at his own risk by weighing the materials and depositing the requisite amount in the Bank account of this office after deduction of the cost of advertisement (Newspaper).
