Expression of Interest for Empanelment of X-Ray Services for Intensified TB Elimination Campaign in Subarnapur district under National Tuberculosis Elimination programme

Interested Agency/vendors with the following prerequisites are requested to submit "Expression of Interest" for empanelment to provide X-Ray services for Intensified TB Elimination Campaign in Subarnapur District. The Intensified TB Elimination Programme is an annual campaign to detect & treat TB for its elimination. This ambitious programme is part of the National Tuberculosis Elimination Programme (NTEP), which focuses on strengthening diagnostics, implementing innovative policies, and engaging private sector and other partners. Chest X-rays (CXRs) plays a crucial role in the elimination of Tuberculosis (TB) by serving as a primary screening and triage tool. It helps in prioritize those who need further testing, like NAAT for drug-susceptible testing. Early detection of TB, enabled by CXRs, is crucial for preventing the spread of the disease and improving patient outcomes. While access to high-quality CXRs is limited in some settings, efforts are underway to improve accessibility, including the use of Static, Mobile & hand-held X rays with the support of Partners

1. Eligibility Criteria:

- The bidder must be an Agency / vendor having valid GST registration/ a Clinical Establishment registered under Clinical Establishment Act.
- The bidder must have a local office in Odisha having valid GST registration with local contact person's address and telephone number.
- The bidder must have minimum one or more Static X- ray Unit / or more Portable x-rays / or more Hand-Held X-Ray machine/s.
- Valid AERB certificate available in case the Agency/ Firms/ Clinical Establishments have Static X- ray/ Portable X-ray machine/s.
- In case of Static X Ray Centre, the Agency/Firms/ Clinical Establishments must have the Centre/s in the Subarnapur district.
- X-ray machines must be registered with the relevant regulatory bodies in India, as mandated by the Medical Device Rules, 2017
- The bidder must have past experience in managing or implementing Govt. health projects successfully at least 1 year or more.
- In case of Digital Hand-Held X-ray Machine following certification are required.
- OEM authorization if applied Firm/ Agency is not manufactures.
- The quoted model must be registered under CDSCO and submit the license to manufacture for sale or for distribution of the medical device.
- It should be AERB Type Approved.
- ISO 13485 certificate issued from a notified body or ICMED 13485 (with or without plus) certificate issued from certification bodies accredited by NABCB or ISO 13485 certificate issued from certification bodies accredited by NABCB / Nationally Recognized Accreditation Board under IAF MLA.
- The model also has Electrical Safety Standards: IEC 60601.
- Relevant Certification for AI generated report.
- X-Ray shall be conducted by qualified Radiographer.
- Radiologist either available physically or connected remotely to issue report with Signature & seal.
- The bidder should submit the required Tender cost Money of Rupees.Rs.5,000/- (Five thousand) only (Non-refundable) should be submitted in the shape of a Demand Draft only in favor of ZSS NON NRHM Fund Subarnapur from any Nationalized/Scheduled Bank payable at Subarnapur.
- The bidder should submit Earnest Money Deposit (EMD) of Rs. 50,000/- (Rupees fifty thousand) Only (Refundable to un-success Bidder after tender process complete). The EMD should be

Modalities of Implementation & Price per X Ray


- The Agencies/Firms/Clinical Establishments shall reach out to vulnerable Population for X- Ray at their door step (i.e. nearest PHC/UPHC/SC) or mobilize the cases to attend Static X-ray Centre/s.
- The health administration shall provide space at health facility for organizing camp for X ray (in case of hand-held X ray device).
- The health administration shall also share Camp schedule with dates to the agency (for hand held & mobile X rays) for smooth management of the programme.
- There is no provision of transportation cost in any form to mobilize eligible cases to centers for X-Rays.
- An amount of Rs.250/- shall be paid per X-ray which includes Manpower Cost, Machine cost, GST and other charges, if any.
- The agency shall share report in hard copy signed duly by Radiologist in case of Static & mobile center and AI generated report for hand held X-ray.
- The X-Ray wise details of the bills and other related documents as desired by the authority shall be submitted to the district office for release of payment on monthly basis. The payment shall be released within 15 days of submission of bills & related documents if same is in order/ as per the requirement.
- The agency to conduct the X-Ray activities with due permission of the authority every month.

Eligibility/Period for Empanelment

The empanelment would be for the period of minimum 2 years (Co-terminus with Financial year) which can be extended for another one year, if performed satisfactorily as per the expectation of appropriate Authority.

Other Conditions

- Eligible bidders should submit their tender documents to O/O- CDM & PHO, SUBARNAPUR, At/Po/Dist-SUBARNAPUR - 762014 through Speed Post / Registered Post on or before 05.00PM on Dt...10.09.2025.....
- Any tender documents received after the due date & time will be rejected and returned to the sender unopened.
- The bids will be opened on dt...16.09.2025..... At 11.00 AM at office of the undersigned and empanelment will be finalized.


