Consequent upon the Advertisement dated 15.05.2025, the following candidates have been successfully qualified in the written examination held on 14.12.2025 for the post of Junior Clerk-cum-Copyist, Junior Typist and Stenographer Grade-III in the judgeship of Sonepur.

The candidates qualified for the post of Junior Clerk-cum-Copyist shall appear in the Computer Science Test (Practical). The candidates qualified for the post of Stenographer Grade-III shall be examined in short hand and Type writing test and those candidates qualified for the post of Junior Typist shall be examined in Type writing test. The candidates selected in the aforesaid test as applicable to Stenographer Grade-III and Junior Typist shall be called for to appear in Computer Science Test (Practical).

Further, the candidates those who got selected in the above tests as applicable for the post of Junior Clerk-cum-Copyist, Junior Typist and Stenographer Grade-III shall be called for to appear in the Viva Voce Test subject to verification of their original testimonials.

Note:-It is hereby informed that the skill test, i.e. Stenography Test and Type writing Test is scheduled to be held on 20.02.2026 (Friday) from 04.00 P.M. onwards in the District Court Complex, Sonepur. Further, the said Computer Science Test (Practical) and Viva Voce Test will be held later on.
