NOTIFICATION

Whereas, the provisional notification in Form-XXII of the Odisha Municipal (Delimitation of Wards, Reservation of Seats and Conduct of Election) Rules,1994 showing the division of the Birmaharajpur Notified Area Council into Wards and Reservation of Seats as required under Sub-Section (3) of Section 12 of the Odisha Municipal Act, 1950 was published in the notification bearing No.3012 dated 26.02.2026 for the purpose of giving opportunity to the person to file appeal, if aggrieved against the decision of division of wards and reservation of seats in the said council ;

And whereas, no appeal has been filed before the Appellate Authority against issue of order in the said provisional notification in Form-XXII within the stipulated period as intimated by the State Government in their Letter No.9589, Dated.30.03.2026


Now, therefore, in exercise of the powers conferred by sub-section(3) of Section 12 of the said Act, the District Magistrate, **Subarnapur** do hereby divide the area of the Birmaharajpur Notified Area Council into **17(Seventeen) Wards** as specified in Column(2) of the Statement-I below with the description and boundaries of the said Wards against each in Columns (3) and (4), respectively, thereof for the purpose of ensuing election of councilors to the same and determine the Wards as specified in Column (2) of the Statement-II below in which the seats reserved under section 11 of the said Act shall be set assigned against each in Column (3) thereof.
