The Vehicle must be in good running condition. It should also be able to cover all GPs /Villages of Dunguripali Block in all weathers.
2. The vehicle should have up to date Tax clearance, Insurance coverage & fitness.. The driver of the vehicle should have a valid driving license.
3. The owner of the vehicle should quote the expecting daily hire charges.
4. The maintenance of the vehicle, The salary of the driver & cost of fuel & lubricant shall be borne by the owner concerned.
5. The vehicle shall be stationed at Block Office, Dunguripali premises.
6. The payment of the hire charges for the month shall be made in the succeeding month through A/C payee cheque, or by transfer credit to the respective Bank Account in State Bank of India, Dunguripali only of the vehicle owner only, subject to availability of funds.
