Madam / Sir,

As you aware of the flagship programme of the Government Bikashit Gaon Bikashit Odisha has been implemented across the State since the FY 2024-25 with a budgetary commitment of Rs.5000 crore from FY 2024-25 to 2026-27. In order to remove different bottlenecks that have emerged in course of implementation of the scheme; the Government have brought out suitable amendments to the scheme guidelines to ensure wider civil society participation & hassle-free implementation of the Scheme meant for bridging critical gaps in rural infrastructure so as to pave the way for a strengthened village as a part of the Vikshit Odisha Vision 2036/2047.
